- 5. To organise Trainings Programmes, Workshops, Short Term Courses, Seminars, Conferences, Webcasts/ Webinars and Residential Course for Women members either jointly with other Committees or individually
- 6. To encourage, groom and create opportunities for Women Members to be the Independent Directors in the companies under the provisions of the Companies Act, 2013.
- 7. To visualise and enhance opportunities for Women Members who opt to work on flexible basis
- 8. Updating and maintaining of existing portal of women members.
- 9. To deal with other matter as the Council or the Directorate may consider appropriate.

Key Highlights - CY 2022-23

- 1. Successfully conducted First Ever Placement Programme for Women Chartered Accountants
 - Women placement drive was virtually held at 9 bigger and 12 smaller campus centres
 - ➤ 1613 women candidates &81 organizations registered across India
 - ➤ 1179 vacancies for Flexi-time/Part-time/Work from Home job options across India offered by the organizations
 - > 97 jobs offered by reputed organizations with 50 offers accepted by women candidates
 - Virtual orientation program organised to equip women members with necessary interview/selection skills prior to actual interview dates
- 2. Organised 40 programs under Sky High Symposium virtual weekly series
 - opportunity was provided to over 80 women members to become speakers on technical/non-technical topics and over 120 women members to become coordinators in the program
 - More than 20,000 participants were empowered during the program with average participation of over 550 members
 - > Approx 174 CPE hours
 - VCMs- 16,Webinars- 14,Virtual Programs- 10
- 3. Organised a session on the theme "Women- From Empowerment to Excellence-Contemporary Perspective" as a part of Iconic Day event organised by the Institute of Chartered Accountant of India to commemorate and celebrate "Azadi ka Amrit Mahotsav" on 8th June 2022 at Hotel Lalit, Delhi. Apart from the physical participation from the members, the program witnessed around 18000 virtual participation.



- 4. Contributed in the ICAI Pavilion as part of ICAI in Service of CA Profession Zone to create awareness about the various initiatives of the Committee undertaken for the benefit of Women Chartered Accountants and to take valuable feedback from the WCOA Participants. Several women professionals from across the world visited the WMEC pavilion.
- 5. Organised a special VCM on 8th March 2022 on the occasion of International Women's Day on the theme "Women Professionals Empowerment to Excellence". Around 2250 participants attended the VCM.
- 6. 24 branches across India organised Women's Day program under the aegis of WMEC in the month of March 2022
- 7. 8 branches including Raipur, Mumbai, Surat, Navi Mumbai, Nagpur, Ahmedabad, Thrissur, Siliguri organised Physical Women Empowerment Programs with average participation of around 100 members.
- 8. Organised Networking Meet on Lead to Empower with Automation and Passion at Mumbai as a side line event of WCOA. Around 80 participants physically attended the Networking Meet.
- 9. Organised Virtual Mentorship Programme for Women Members jointly with CPE Committee.
- 10. To celebrate the success of commendable number of women taking & clearing CA final examination, the Committee has initiated process of compiling data of women candidates clearing CA final exam in Nov 2022 examinations and sending them a congratulatory message along with giving them a brief introduction about the Committee.

Significant Achievements & Initiatives of WMEC for the C. Y. 2022-23

International Women's day Celebration

To commemorate International Women's Day i.e. 8th March, 2022, the Committee undertook following activities-

- The committee organized a special VCM on the occasion of International Women's Day. The theme of the VCM was "Women Professionals Empowerment to Excellence," wherein along with panel discussion with eminent Speakers, deliberations on various Initiatives undertaken/ to be taken by ICAI under the aegis of WMEC for capacity building and empowerment of Women Members were done by President ICAI, Vice President ICAI, Chairperson WMEC and Vice-Chairperson-WMEC.
 - The eminent speakers of the VCM included CA Bhavna Doshi-founder partner of Bhavna Doshi & Associates LLP, CA R M Vishakha- MD & CEO, India First Life Insurance Company Limited, CA. Bhavani Balasubramanian- Chief Strategist -Diversity Evaluation for AVTAR and CA. Sangeetha Shankaran Sumesh- CFO turned Business & Leadership Coach. The VCM was attended by over 2250 participants.
- Video bytes of President ICAI, Vice President ICAI, were recorded and uploaded on women portal for the benefit of all the stakeholders at large. The same was also sent to all the branches across India to be telecasted during the women members programme for motivating and inspiring women members across the country.
- 3) An informative social media creative was created and uploaded on social media platforms of the Institute and the Women Members Empowerment Committee to publicize and promote ICAI's initiatives towards women members' empowerment. Along with ICAI initiatives for women members, the creative also included women empowering schemes of Govt. of India.
- 4) In response to the WMEC mass email to branches to promote and conduct events for the benefit of women members at large during the month of March 2022, 24 ICAI branches across the country, conducted Women Empowerment programme under the aegis of WMEC.

First Ever Placement Programme for Flexi-time/Part-time/Work from Home Job Opportunities for Women Chartered Accountants:

Committee organized Placement drive exclusively for women members jointly with Committee for Members in Industry & Business (CMIB) to explore more dedicated placement opportunities for experienced women Chartered Accountants who want to work on a flexi-time/part-time/ work from home basis on 31st October & 1st November, 2022. The programme was held virtually at 9 bigger and 12 smaller centres. The facilitation covered flexi-time/ part-time/work-from-home options and was an excellent opportunity for women members not holding full-time COP and having standing of more



than 1 year, to explore job opportunities as per their ease and comfort ability. An enthusiastic response from 81 Companies with 1179 vacancies to offer flexi-time/ part-time/work-from-home job options for women members was received. 1613 women members registered for the said placement program. 97 Unique offers were made by the recruiters wherein 50 Offers were accepted by the women members.

To help Women CAs registered for First Placement Programme, prepare them for interview and to address their queries and doubts, Committee organized Orientation Programme on 28th October, 2022. Eminent speakers addressed on pertinent topics to guide and mentor members before selection interview/test.

Azadi Ka Amrit Mahotsav- Iconic Day Event

As part of country wide Azadi ka Amrit Mahotsav initiatives, envisaged by Government of India, to commemorate and celebrate 75 years of India's Independence, the Committee organised a seminar on the theme "Women- From Empowerment to Excellence- Contemporary Perspective" as a part of "Iconic Day Event" on 8th June 2022 at Hotel Lalit, Delhi. The seminar had eminent and renowned speakers- Ms Pallavi Kumar- Executive Director- Multi Organ Harvesting Aid Network (MOHAN) Foundation-Delhi NCR; and Dr Bornali Bhandari- Senior Fellow at National Council of Applied Economic Research (NCAER). Apart from the physical participation from the members, the program witnessed around 18000 virtual participation.

Virtual Mentorship Programme for Women Members

Committee organised Virtual Mentorship Programme for Women Members jointly with CPE Committee on 25th August 2022. Following topics were covered- Online Opportunities for Women Members, How to develop Growth Mindset, Importance of health - both physical and mental (emotion management - enthusiasm - bouncing back - mindfulness - always energetic - fearless soul), Taking break - sabbatical or long inactive break from professional or entrepreneur life as positive rather than setback, Action - coming out of comfort zone, Subsidies - State - National and International - WTO Practice, Entrepreneurship- Virtual Global Consultancy & How to create Online Course and Technology for Teaching. Eminent speakers were invited in the program to deliberate on these pertinent topics.

Networking Meet on Lead to Empower with Automation and Passion

Committee organised Networking Meet on Lead to Empower with Automation and Passion (LEAP) on 16th November, 2022 at ICAI Auditorium, BKC, Mumbai as a side line event of WCOA. WCOA Pavilion

Committee contributed in the ICAI Pavilion as part of ICAI in Service of CA Profession Zone. The purpose of participating in the ICAI Pavilion was to create awareness about the various initiatives of the Committee undertaken for the benefit of Women Chartered Accountants and to take valuable feedback from the WCOA Participants. Various initiatives of WMEC were highlighted during interaction with the visiting delegates. A PPT compilation of various initiatives was also designed to be showcased in the Pavilion area. Women CAs were encouraged for their active participation in the programs/seminars/ webinars/VCMs of the Committee and to visit Women Portal regularly so that they are aware of the upcoming initiatives of WMEC.A quiz consisting of 30 questions was conceptualised and framed keeping in mind both International and domestic participants. Attractive Flash Cards were designed for each question and 4 sets of the same were printed for distribution to the interested participants of the quiz. Along with Action plan of the Committee, sustainable gift items i.e. Handbags/Sling bags were distributed to generate awareness and interest in the Committee activities to Indian as well as foreign delegates who participated in the quiz and showed interest. Approx 1000 women professionals from across the world visited the pavilion and enquired about WMEC initiatives.

Sky High Symposium

Committee organised around 40 programs under its Sky High Symposium Series. Sky high symposium is a Wednesday series of programs conducted by the Committee for the women and by the women. It is one of the WMEC's initiatives to not only disseminate information to women members on technical updation and non-technical skills but also to empower and inspire women members to come at forefront and realise their verbal skills at public forum. The sessions were taken up by eminent Speakers on pertinent technical as well as non-technical topics with average participation of over 550 members wherein opportunity was provided to over 80 women members to become speakers on technical / non-technical topics and over 120 women members to become coordinators in the program.


