Key Highlights – CY 2024-25

1. Successfully organised 2nd CA Women Excellence Awards on 1st February 2025 to acknowledge, recognize and reward the indispensable contribution of women members in various professional arenas. Encouraging response was received from 105 women members who were nominated in different 5 categories.
2. Relaunched flexi & part time Portal for CA Women, CA Firms & Corporates for streamlining job matching. Key features of the portal are its personalised dashboard, user friendly interface, anywhere, anytime accessibility, diverse opportunities etc. API integration accelerates registration by auto-capturing data from SSP portal. More than 600 employers and more than 9000 women members registered on the portal.
3. Led the successful organization of the CA Women Leadership Conclave, "Falcon," which attracted over 500 women Chartered Accountants. This pioneering event, followed by the Falcon series 2.0, 3.0, 4.0, 5.0 and 6.0 empowered women professionals through knowledge exchange, leadership discussions and networking opportunities with prominent leaders from diverse fields.
4. Successfully released the publication titled "The Future is Female and It's Now," focusing on various aspects of women leadership.

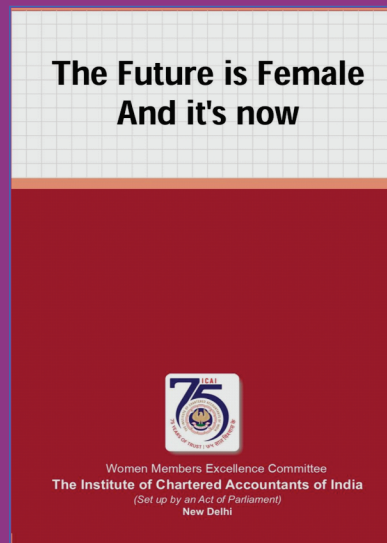


Independent Directors' Conclave

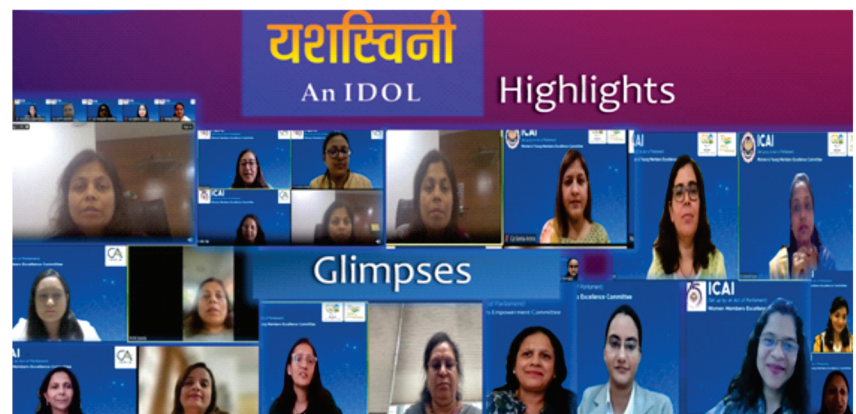

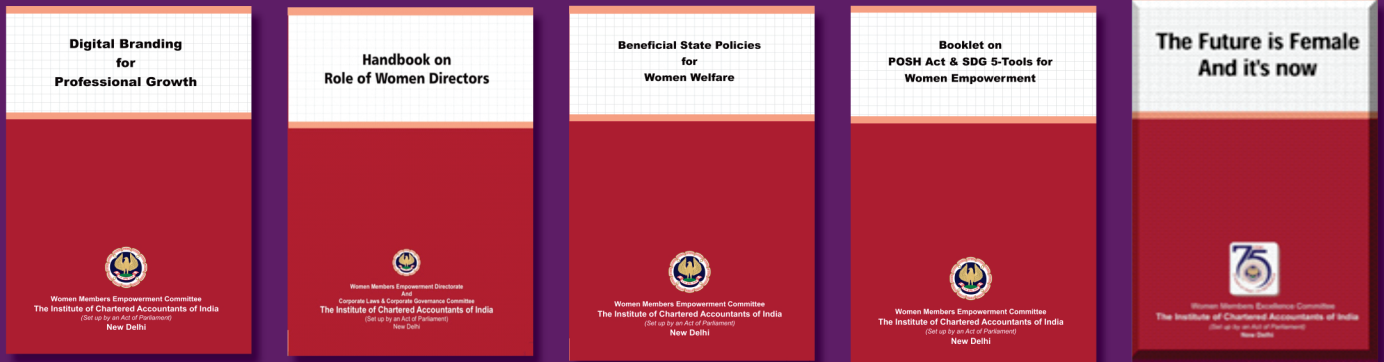
